- The Board approved a Storm Water Proposal from Allen Engineering and Science, Inc. for a fee not to exceed \$21,000.
- The Board approved the preliminary Plat for East Bay of Caroline.
- The Board approved a resolution for a regional partnership with Madison County, Hinds County, City of Ridgeland, City of Jackson, and the Madison County Economic Development Authority regarding improvements to the West County Line Transportation Corridor.
- The Board approved the Scope of Work, to be completed by Pickering Engineering, for the FY 2026 United States Department of Transportation Build Grant application.
- The Board approved an amended Cooperation Agreement between Madison County and the Town of Flora for paving Pocahontas Road.
