## Madison County Board of Supervisors Meeting Quick Notes: May 6, 2024

- The Madison County Board of Supervisors, "the Board", adopted a long-term transportation system plan that includes five laning Yandell Road to Highway 43, widening Stribling Road from Catlett Road to Highway 463, finishing Reunion Phase 2 (the overpass over I-55), finishing Reunion Phase 3 (from Highway 51 to Parkway East), widening Bozeman Road from Highway 463 to Gluckstadt Road, widening Catlett Road, widening Weisenberger Road, widening West County Line Road, and widening Wheatley Street.
- Central District Transportation Commissioner Willie Simmons addressed the Board about infrastructure issues. We will be posting his remarks, via video, onto our Facebook page.
- The Board added the following roads and streets to the funded FY 2024 road plan:
  - Coker Road for \$290,000
  - Jackson Street for \$52,000
  - Hawkins Thompson Lane for \$54,000
  - Katherine Point Drive and Twin Lakes Circle for \$115,000
  - Wheatley Street for \$487,000
  - Lep Childress Road for \$108,000
  - Old Highway 17 for \$220,000
  - Channing Circle for \$75,000
- The Board entered into a cooperation agreement between the County and the City of Canton for road and street work on:
  - East Academy Street for \$82,816
  - East Semmes Street for \$31,800
  - Montgomery Lane for \$27,000
  - Smith Vaniz Court for \$19,337
  - South Monroe Street and Kathy Circle for \$80,440

Madison County Public Works will perform the work in conjunction with the Canton Public Works Department.

- The Board passed a resolution awarding the City of Ridgeland \$2mm for the "Colony Park Boulevard" sewer improvement project. The funds will be awarded from the County's American Rescue Plan Act (ARPA) funds.
- The Board approved moving forward with design and renovation of the Circuit Courthouse.

- To decrease voting lines and time at the Fairview voting precinct, the Board designated the Deerfield Clubhouse as a voting precinct. The Circuit Clerk's office will let voters know if their voting precinct changes.
- On behalf of the Megasite Fire District, the Board supported their concept for a Fire Training Center to enhance the protection of industrial, commercial, personal and education sectors within the district. This will allow firefighters to train together in the event of a mutual aid emergency.
- Sheriff Randy Tucker announced that the Madison County Sheriff's Office will start an internship program for college-age students who are interested in law enforcement as a career.
- The Board awarded the Softball Complex at Sulphur Springs Park to England Enterprises, Inc. in the amount of \$1,822,000. In addition, an irrigation system was approved for the fields.
- The Board approved approximately \$354,000 for the City of Ridgeland and approximately \$143,00 for the City of Gluckstadt for emergency communications equipment.
- The Board approved the plat for Camden Glen. The development contains 8 lots on 20.25 acres.
- The Board approved allowing Hemphill Construction Company to subcontract work to Russo Corporation.
- The Board approved the preliminary plat for Westpointe Phases 1 and 2.
