- New Complaint, Petition Fee: Circuit Court & County Court - **\$161.00 per case**
- Petition for Review of Driver's License Suspension - **\$161.00**
- Petition for Hardship License - **\$181.00**
 - Circuit - There is no alcohol hardship license since 10/1/14 (Section 63-11-30(2)). For drug related DUI, Section 63-1-71 provides a **\$20** assessment.
- Supreme Court Appeal - **\$200.00**
- Request for Out of State Subpoena - **\$161.00**
 - It is required to open a new civil case according to the Mississippi Rules of Civil Procedure. Filer must provide a certified copy of order from other court for subpoena to be produced, along with a subpoena styled in this court.
- Notice of enrollment of a Foreign Judgment - **\$161.00**
 - Must provide a Civil Cover Sheet, Acts of Congress, certified copy of judgment to be enrolled, and last known address of the parties.
- Filing Each Suggestion for Writ of Garnishment, Writ of Execution, Judgment Debtor Actions and Renewal of Judgment - **\$36.00**
- Transfer Fee - **\$88.00**
- Appeal from County to Circuit Court, on the record - **\$85.00**
- Appeal - Administrative Agency, on the record - **\$85.00**
- Appeal from Justice Court or Municipal Court to County Court (Civil) - **\$85.00 plus 125% of judgment to be paid at the time of filing the appeal**
 - Must provide the appeal cost sheet from the lower court.
- Abstract or Enroll a Judgment - **\$5.00**; Requesting Abstract - **\$1.50**; Cancellation of Abstract - **\$1.00**
- Act of Congress - **\$3.00**

MARRIAGE

- Marriage License - **\$37.00**
- Certified Copy of License - **\$17.00**
 - **+\$6.00** for each additional copy when purchased on the same day.

RECORD REQUEST

- Marriage Records Search - **\$10.00 per name**
- Civil Records Search - **\$10.00 per name**
- Criminal Records Search - **\$10.00 per name**

CRIMINAL

- Post-Conviction Relief - **\$161.00**
- Petition to Contest Forfeiture - **\$161.00**
- Supreme Court Appeal - **\$200.00**
- Appeal from Justice Court or Municipal Court to County Court (Criminal) - **\$85.00 plus appearance bond and cost bond**
 - Appearance bond and cost bond amounts are set by the lower court. Filer must provide the cost sheet(s) from the lower court.
- Criminal Fines, Fees, & Assessment Payments - **Unique to each case. Call the Clerk's office if you do not know how much you owe.**
 - Can NOT be paid over the phone.
 - Can be paid in person with cash (must provide EXACT change) or card. There will be an extra 2.3% fee for payments made by card.
 - Payments can also be sent by mail. Mailed payments must be paid by money order. Include your name and case number on the money order. You may call the Clerk's office if you do not remember your case number.

EXPUNGEMENTS

- If filed pursuant to 99-15-26 (standard non-adjudication statute for non-drug crimes, or for cases in which an arrest was made but no disposition, or the defendant found not guilty, or charges dismissed; Completion of Pretrial Diversion Program) - **\$161.00**
- If filed pursuant to 41-29-150 (non-adjudication statute for drug crimes) - **\$161.00**
- If filed pursuant to 99-19-71 (CONVICTIONS) - **\$311.00**
